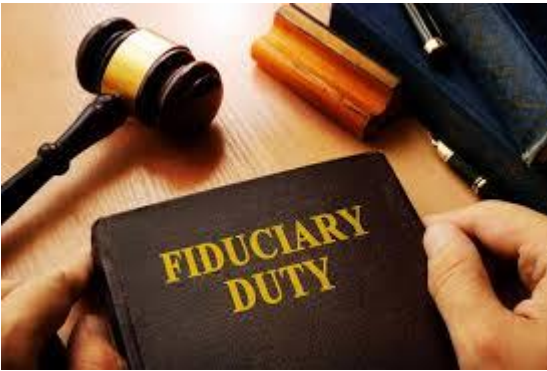

# Who is LESI?

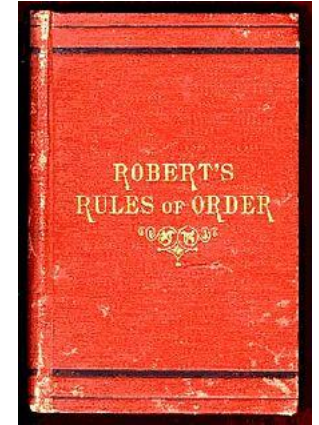
- ❑ LSC's, or *Local Swimming Committees*, are the 59 local governing bodies, responsible for organizing, supporting and governing USA Swimming's 3,000-plus swim clubs in their individual regions.
- ❑ Lake Erie Swimming includes the following geographic areas: In the State of Ohio, the counties of Seneca, Crawford, Erie, Huron, Richland, Lorain, Ashland, Cuyahoga, Medina, Wayne, Summit, Lake, Geauga, Portage, Stark, Tuscarawas, Ashtabula, Trumbull, and Mahoning\_
- ❑ Lake Erie Swimming is a member of Central Zone
- ❑ There are 15 LSC's in the Central Zone: Arkansas, Illinois, Indiana, Iowa, Lake Erie, Michigan, Midwestern,, Minnesota, Missouri Valley, North Dakota, Ohio, Oklahoma, Ozark, South Dakota, Wisconsin.

- **Requesting Points of Something**

Certain situations need attention during the meeting, but they don't require a motion, second, debate or voting. It's permissible to state a point during a meeting where the chairperson needs to handle a situation right away. Board members can declare a Point of Order, Point of Information, Point of Inquiry or Point of Personal Privilege.
